Codsiga ka badbaadinta la wareegidda Gurigaaga oo lala wareego, waa in aad buuxisaa codsigaan ka si laguugo ogolaado codsigaaga waxaa lagaaga baahan yahay:

- In aad ka mid tahay Dadka leh Guriga ee ku qoran Codsigaan ama aad Qaraabo tihii Qof ka mid ah Dadka leh Guriga
- Ama aad si joogta ah u degan tahay Gurigan kor ku qoran
- Ama aad ku nooshahay Gobolka Minnesota.

Si loo ogolaado Qaraabanimadiina waa in aad tahay Qofka Guriga leh Waalidkii, Ilmahiisa, Awoowgiis, Caruurta uu Awoowga u yahay, Walaalkii, Eedo, Adeer, Caruurta uu Adeer/Abtiga u yahay, xataa marka lagu daro kuwa uu xiriirka Guurku idin qaraabeeyey.

Qiimeeyahaaga ayaa waxaa uu Go'aan ka gaari doonaa haddii aad xaq u leedahay in lagu Ogolaado ka Badbaadinta la Wareegidda Gurigaaga, Waxaa kale oo laga yaabaa in lagu ogolaado Deganaashaha Gobolka Minnesota haddii arimahan hoos ku qoran qaar ama kuli ay ku khuseeyaan:

- Haddii Codkaaga Doorashada aad ka Dhiibato Gobolka Minnesota;

- Haddii aadan si Sharci ah u Deganayn Gobol kale oo ka mid ah Gobolada Waddanka.

Sharcigu waxaa uu caddeynayaa in loo baahanyahay in aad keento "Shahaddada Qiimaha Guriga" si aad xaq ugu yeelato in lagu ogolaado Ka Badbaadinta la wareegidda Guriga (Xeerka Minn. 272.115)

Xeerka Minn. 273.124, Qaybta 13. Waxay caddeyneysaa in loo bahanyahay lambarada Social Securitiga iyo Saxiixyada Dadka leh Guriga loo baahanyahay in laga Badbaadiyo La Wareegidda. Haddiise Guriga uu yahay Guri ay si Joogta ah u degen yihiin Qaraabadaada waxa loo baahan yahay Lambarada Social Securitigooda iyo Saxiixooda, isla markaana waa in Dadka Guriga iska leh Isaga/lyada hadba qofka ay dadkaas Qaraabada yihiin uu kula qoran yahay Codsiga, haddii ay warqaddu idiin qaadi weydo isticmaal warqad kale oo ku lifaaq Codsiga.

Social Securitigu waa Lambar Sir ama Qarsoodi ah sida uu qabo Xeerka kor ku qoran, waxaa laga yaaba in Qiimeeyahaaga uu bixiyo Lambarkaas oo uu siiyo Hayadda Canshuur Celinta Gobolka Minnesota, si loo Hubiyo in Adiga iyo Qofka aad Qaraabada tihii ee Guriga leh aydan Codsiga kale oo ka Badbaadinta la Wareegid Guri ka codsan Guryo kale oo Gobolka Minnesota ku yaal.

Inta badan Dadka leh/Degan Guryaha ma helaan Warqadda Codsiga ka Badbaadinta Lawareegidda Guryaha Sannadwalba. waxaase laga yaaba in Qiimeeyahaaga uu marka uu doono kaa codsado in aad codsi kale oo ka Badbaadinta la Wareegidda Guryaha soo dirtaa si ay Fursaddaada Xaq u helida ka Badbaadinta La Wareegidda guriga ay u Jirto.
