Bulk data field descriptions

Field	Description
OBJECTID	Unique identifier for open data portal
HealthFacilityIDNumber	Unique identification number for the facility
FacilityCategory	Type of facility based on use. "Restaurant" includes bars, coffee shops, prepared food departments inside grocery and convenient stores. "Grocery" includes traditional grocery stores, convenient stores, grab-and-go sections within hotels, and stores selling only prepackaged items. "Institution" includes schools, short-term care facilities, child and adult care facilities. One business may have multiple facilities under the same roof. For example, a larger grocery store will often have a "restaurant", a "meat market", and a "grocery" facility.
BusinessName	Name of the business
RiskLevel	Categorization of facilities depending upon food preparation methods. This risk level determines how often the facility is inspected and is not determined through previous performance on inspections. Risk 1 facilities are typically full-service restaurants. Risk 2 facilities are restaurants that do not prepare large amounts of food in advance. Risk 3 facilities are very limited in their handling of food, often serving pre-packaged items.

StreetName	Street name
StreetType	Type of street (Ave., St. Ln., etc.)
PostDir	Street direction that comes after the street name (N, S, NE, SW, etc.)

InspectionType	Type of inspection. "Routine" inspections are done with set frequencies. "Follow-Up" inspections are based off of the previous "Inspection Score".
InspectionResult	Result of inspection
DateofInspection	Date and approximate time inspection was completed
InspectionIDNumber	Unique identification number for the inspection
FoodCodeText	Description of violation
InspectorComments	Inspector's observations related to the violation
ViolationPriority	Severity of the violation. "Priority1" violations are the most serious.
FoodCodeItem	Minnesota Rule Chapter 4626 or Minneapolis Code of Ordinances reference for violation

Open Data Field Descriptions (cont.)

Field	Description
YearOfInspection	Year the inspection was completed
ViolationStatus	Status of the violation at the time of the inspection
ViolationPoints	Point value of the individual violation based on "Violation Priority" and "Violation Status".
InspectionScore	100 minus the sum of "Violation Points" for each inspection. Over the date range contained in this data set, the method for calculating "Inspection Score" has changed. The "Inspection Score" in this dataset is calculated using the current method to most accurately compare inspections over time.
ViolationIDNumber	Unique identification number for the instance of the individual violation
APN	13 digit tax identification for parcel
Ward	Ward number where facility is located
Neighborhood	Neighborhood where the facility is located
Latitude	X coordinate of the parcel
Longitude	Y coordinate of the parcel
X_WebMercator	X coordinate of the parcel for web mapping
Y_WebMercator	Y coordinate of the parcel for web mapping
